**RESPECT FOR ALL AT THE DEN SYC**  
**CODE OF CONDUCT**

The staff and volunteers at The Den SYC strive to make our space and programs inclusive, safe and fun for everyone. The following procedures are in place to support youth while accessing programs with The Den SYC.

**Signing In/Signing Out**

All youth must sign in when they arrive and sign out when they leave.

**Behavior: Chances**

We want to create and maintain an atmosphere of physical and emotional safety for all, staff and youth, while we are in operation (this includes off-site programs as well). As such, when the safety principles and values are not followed, youth will be given three chances to change their behavior. If the youth does not change their behavior after all three chances are used, staff retain the right to ask youth to leave at their discretion especially when youth behaviors are posing imminent danger to themselves or others.

➤ **Language**

All language should be inclusive and appropriate for everyone at LCYC. We serve youth grades 7 to 12; therefore, we ask that youth be mindful of the difference in ages when they are talking with their friends. If youth are swearing at each other, or cutting anyone down, staff will implement the 3-chance system.

➤ **Tobacco & Vaporizers**

There is a zero tolerance for tobacco use and vaporizing on The Den SYC property. Property includes the front, back and patio areas around the building. If youth are leaving the building to smoke, we ask that you go for a walk and not loiter.

➤ **Drugs/Alcohol**

All alcohol, drugs, and energy drinks are not permitted for use on The Den SYC property. If youth have possession or are expected to be intoxicated, staff/volunteers have the right to remove the youth(s) for the night. RCMP may also be contacted at the discretion of the Program Director.

➤ **Fighting/Bullying/Aggressive Behavior**

Physical contact, and/or aggressive behavior is strictly prohibited at The Den SYC. Youth involved in serious fights, and their bystanders, will be asked to leave for the evening. An incident report will be completed by personnel. There is zero tolerance for an obvious use of a weapon, either threatening or attempt to use. If necessary, the police will be contacted to deal with the situation.
